## BLACK HISTORY MONTH

The history of the efforts of abolitionists is often tied to Quakers, and we believe that many Friends were an important piece of the puzzle. That being said, what makes Byberry Hall different from some, if not most, of the other local purpose-built abolition debate halls, was the fact that Byberry Hall was built, not by white Quakers, but



by Robert and Harriet Purvis, two of the most influential people of color in the Underground Railroad efforts. As neighbors of Byberry Meeting, Harriet and Robert had participated in many "discussions" at our Meeting, in efforts towards the eradication of slavery, and they knew that these discussions were encouraged, welcomed, and critical. This discernment also benefitted by the many other efforts put forth, including Robert serving as President of Pennsylvania Anti-Slavery Society; he was also a founder of the Vigilant Committee of Philadelphia. Harriet was her own force with which to be reckoned, as a founder of the Phila Female Anti-Slavery Society.

As we continue to assess the structure of Byberry Hall (with tremendous gratitude to the State of Pennsylvania Keystone Grant), we fully expect we will be undertaking

numerous restoration projects to ensure the preservation of this critical piece of history, created and supported by Robert & Harriet Purvis, not just to the history of the Northeast of Philadelphia, but our state and the country.


